The National Federation is hosting a two-day conference entitled "Autonomous Accountability" – May 30<sup>th</sup> & 31<sup>st</sup> 2018

The National Federation will host a very important conference entitled "Autonomous Accountability" on Wednesday 30<sup>th</sup> & Thursday 31<sup>st</sup> May, 2018 in the Mullingar Park Hotel. Concerns have been expressed about a continuing role for the voluntary sector in the provision of supports to people with intellectual disabilities in this state. Does the state value this role and, if so, how best do Voluntary Services Providers ensure that accountability and compliance requirements are met in a way that allows providers to stay focussed on their primary purpose?

The conference will address the following core issues:

- 1. Whether the State identifies as a matter of policy a continuing role for voluntary bodies in the disability sector?
- 2. What is the value-add / public good the State and informed commentators identify as flowing from this policy objective?
- 3. What governance and operational paradigms are appropriate and fit-for-purpose to promote and safeguard this value-adding contribution?
- 4. What is the vision for the future?

As well as seeking confirmation by the State of a continuing role for voluntary organisations providing services to people with intellectual disability the conference will aim:

• To counter the general assumption that the role of voluntary board is to be the state's compliance checking 'eyes and ears' inside the organisations;

- To promote a recognition by governmental agencies that there are approaches to governance other than an exclusive focus on conformance;
- To challenge the assumption that the managerialist approach stripping public services of moral and ethical values and replacing them with the market language of costs, efficiencies and competition – is the only available approach and a fit-for-purpose approach to leading and managing organisations.

This timely conference will include a range of national and international speakers. It will explore approaches to Governance and compliance operating in other jurisdictions including a consideration of the 'experimental approach' to Governance which combines clarity of objectives with flexibility and diversity of approach in the achievement of these objects.

We expect a large and diverse audience including senior management and staff of Voluntary Organisations, Chairs and Board Members of Voluntary Organisations, representatives from HSE, HIQA, Department of Health, Department of Public Expenditure and Reform, leaders and senior managers from the national disability representative organisations and self-advocates.

A programme and online booking will be issued shortly.

### Assisted Decision-Making (Capacity) Act Seminar

Event exploring finances and the Assisted Decision-Making (Capacity) Act, 7 March 2018

There was a full house for the National Federation's seminar on Wednesday 7<sup>th</sup> March 2018, arranged for members to explore the implications of the Assisted Decision-Making Capacity Act for service provider organisations. The focus of this seminar was on exploring ways in which the funds belonging to users of services can, and should be accessed, and managed for the benefit of the person; and how this relates to various processes (e.g. applications for aids and appliances).

The seminar took place in Moore Abbey, Monasterevin and was facilitated by Ms. Mary Condell, Legal Advisor with Sage. Mary is a practicing solicitor and mediator with a particular interest in legal and other issues concerning older adults and adults with disabilities. She is also a member of the Law Society's Task Force on Mental Capacity which was established to review and make submissions on new capacity legislation and of the National Financial Abuse of Older People Working Group.

Mary set out the context to understanding of capacity within the Act, and ways in which this may be interpreted in relation to supporting people to access their money in a way that is transparent and accountable, when there are difficulties with capacity.

A number of potential models for the process of managing finances on behalf and in support of the person were put forward, and it was agreed that the National Federation will engage in further work in consultation with Mary Condell and a range of key stakeholders, to explore this issue further in advance of the consideration of these issues by the newly-established Decision Support Service. As the commencement and implementation of the Assisted Decision-Making (Capacity) Act continues it is the intention of the National Federation to hold further learning events.

#### **Inclusive Research Network**

#### 2018 Where We are

The IRN got off to a busy start in 2018 with more Focus Group Training taking place in Trinity College Dublin on 17<sup>th</sup> January. IRN Members are practicing asking the questions and running the focus groups through the use of 'role play'. We are finding it difficult to be the person



asking questions instead of answering them and so, some more time is needed with this. These focus groups will gather information from people with intellectual disability about what it is like for them to attend their doctor and will feed into our 'Doctors and Us' research project.

The IRN agreed that Dr. Nancy Salmon, University of Limerick, will represent the IRN and make the presentation as the conference organisers are only funding one person to attend. Nancy Leddin, Chair and Carol Ann O' Toole are helping in preparing the presentation. IRN Secretary Brian Donohoe has written to the conference organisers about future invitations as it is important that funding is provided so that members of the IRN are supported to attend such events.

The IRN is working on an abstract for a conference in Halifax, Canada called 'Healthy Living, Health Lives'. If successful some IRN members will join via video link and make a presentation on our current research project 'Doctors and Us'.

An article is also being written for the British Journal of Learning Disabilities about the 2015 'Our Homes' research project – Brian Donohoe, Laura Murray and Greg Singleton are co-editors with Dr. Nancy Salmon, University of Limerick. The IRN is also writing an article 'How IRN works' with Dr. Edurne Garcia, Trinity College Dublin.

#### **HIQA Providers Forum**

The Health Information and Quality Authority (HIQA) is responsible for the inspection and registration of designated centre for adults and children with disabilities and the HIQA Providers Forum was established in 2014 to facilitate communication between the Authority and representative organisations of Service Providers. Membership of the Forum includes the National Federation of Voluntary Bodies, the



Disability Federation of Ireland, the Not for Profit Business Association, the Irish Council for Social Housing and the Health Service Executive. In particular the work of the Forum focuses on:

- Provision of updates on the implementation of the regulatory processes, policy direction and registration programme for residential services for children and adults with disabilities.
- > Presentation by Service Providers of wider queries and information items generated from membership for clarity.

The National Federation is currently represented on the HIQA Providers Forum by Anna Shakespeare, CEO, St. Michael's House / Chairperson, Quality & Standards Sub Committee, Brian O'Donnell and Jillian Sexton, National Federation Secretariat.

# HIQA Draft national infection prevention and control standards for community services

HIQA has developed draft national infection prevention and control standards for community services. A public consultation on these draft standards commenced on the 31<sup>st</sup> of January and the National Federation made a submission to same. Once finalised and approved by the Minister for Health the standards will become nationally mandated which means that designated centres will be required to begin implementing these standards and working towards achieving compliance with them.

#### **HIQA Thematic Inspections – Restrictive Practices**

In late 2018 HIQA will begin a programme of thematic inspections focusing on the use of restrictive practices in Designated Centres. HIQA is seeking to ensure that the development of this thematic inspection programme is informed by personnel who have particular expertise in this area and so

have established an expert advisory group to guide this work. HIQA circulated a 'baseline survey' to all designated centres in late 2017 which sought to gather information in relation to the type / frequency of physical and environmental restraints used within the last year. The survey also sought information in relation to organisation's policies / governance on the use of restrictive practices and the type of training provided to staff on the safe and appropriate use of restrictive practices and restraints.

As further information is made available in relation to this thematic inspection process it will be circulated to relevant organisations.

There was a large attendance at the workshop and feedback from the workshop was very positive. The workshop was also useful in identifying topics for future workshops/training / development on issues relating to Health & Safety.



### **Safeguarding Updates**

# HIQA - New standards on safeguarding adults who may be at risk





the draft national standards includes all health and social care services. HIQA and the MHC are now consulting with key stakeholders to obtain their expert opinion as to what they believe to be the priority areas for safeguarding adults. They are also seeking advice on engaging stakeholders


through identifying frontline staff and people who use services to participate in focus groups and raising awareness among colleagues of a public consultation on the draft standards, all of which will inform the development of the final standards.

A Steering Group for the project has been established, which comprises representatives from the MHC, HIQA and the National Safeguarding Committee. The National Federation of Voluntary Bodies has been invited to nominate a representative to this Steering Group. A systematic literature review of published evidence in the area of safeguarding has started and will form part of the evidence-base that will inform the development of the standards.

#### 'Safeguarding Vulnerable Persons at Risk of Abuse' - Online Course

The 'Safeguarding Vulnerable Persons at Risk of Abuse' online course aims to increase the knowledge and skills of staff/volunteers in relation to safeguarding vulnerable persons and dealing with safeguarding incidents when they arise. In particular, the online course focuses on the "Safeguarding Vulnerable Persons at Risk of Abuse, National Policy & Procedures" document published by the HSE in December 2014 and sets out the procedures to be followed when a safeguarding concern arises. A key feature of the course is the emphasis placed on organisational culture and the importance of the creation of an open culture - "culture manifests what is important, valued and accepted in an organisation. It is not easily changed nor is it susceptible to change merely by a pronouncement, command or the declaration of a new vision. At its most basic it can be reduced to the observation the way things are done around here".



The course seeks to ensure that staff/volunteers are clear that safeguarding is **everyone's** responsibility.

Key areas covered within the online Safeguarding Course include the following:

- Defining the key terms of safeguarding vulnerable persons at risk of abuse
- Organisational Culture
- > The features of a positive organisational culture
- Everyone has a role in safeguarding
- Reporting Abuse
- Do's and Don'ts of Safeguarding

The online Safeguarding Course aims to compliment the ½ day 'face-to-face' Safeguarding Awareness Training Programme developed by the National Safeguarding Office (it does not replace it) and takes approx. 90 minutes to complete. The online course will be of particular interest to

'Persons in Charge' (PIC's), Designated Officers & Team Leaders and can be used in a variety of ways including:

- Induction training for new staff or volunteers,
- Provision of refresher training for staff / volunteers,
- 'Just-in-time' training (i.e. a safeguarding incident occurs),
- Team meeting discussions.

The online Safeguarding course can now be accessed via the following 2 routes:

- 1) Free Resource: The course is available as a free resource for all organisations via the following link: http://yourotc.net (scroll down) until January 2019. You can progress through the course systematically or immediately access any part of the course that contains the materials you want to review. Note: The open access route does not monitor an individual's completion of the course.
- 2) Monitoring / Certification: If you are a manager and you would like the opportunity to monitor a group of staff or an individual staff member's progress through the course, the Open Training College can assist. The Open Training College is offering tracking and certification for course completion for the purposes of CPD for staff at all levels. To discuss the process and cost

The online Safeguarding Course was developed by the National Federation, St. Michael's House and the Open Training College as part of a Pobal Project funded under the Dormant Account Funds.

Completion of this course provides the information you require to support your practice until you have to complete the HSE Safeguarding Vulnerable Persons classroom- based course. It is not a substitute for it.

#### **Mid-West Safeguarding Action Plan**

The HSE launched its Safeguarding Vulnerable Persons at Risk of Abuse Policy in late 2014 in response to concerns relating to vulnerable adults. One of the recommendations of the policy was the establishment of a Safeguarding and Protection Committee in National Safeguarding Office each Community Health Care organisation. This was in




recognition of the fact that safeguarding is not the sole responsibility of one agency but rather a realisation that safeguarding and the promotion of people's rights are issues of interest to all.

The Mid-West Interagency Safeguarding Committee was established in 2017 under the Chairmanship of Paschal Moynihan, Head of Social Care, HSE with multi agency representation from the statutory, voluntary and business sector. The purpose of the committee is to promote the rights and independence of vulnerable adults and help safeguard them from abuse. The committee aims to do this through education, promotion, information sharing, public awareness and policy development.

On 23<sup>rd</sup> March this year the committee formally launches its 3 year Action Plan. The Plan outlines the objectives and actions of the group over the period 2018 to 2020. The plan was developed in collaboration with all the agencies and their representatives and there is commitment from all to support the plan.

#### **Adult Safeguarding Policy**



The Review of the National Safeguarding Policy is continuing and is due to be completed by June, 2018.

The most recent meeting of the HSE / Disability Umbrella Groups Safeguarding Reference Group took place on March 2<sup>nd</sup> last - there remain considerable challenges for organisations in implementing the National Safeguarding Policy including the need to introduce thresholds for reporting, organisations being held responsible for investigating incidents which arise outside of the service setting, resource pressures, etc.

#### **Children First**

Key issues that organisations should be aware of in relation to 'Children First' and implementation of the provisions of the Children First Act, 2015 include the following:



- ✓ Child Safeguarding Statements / Risk Assessments: The Children First Act requires that all relevant services (Schedule 1 of the Act) should have completed child safeguarding risk assessments and published their Child Safeguarding Statement within 3 months from the commencement of the Act i.e. by 11<sup>th</sup> March 2018.
- ✓ **Mandatory Reporting**: Organisations need to ensure that staff members who fall under the mandatory reporting provision are clear in relation to their role / responsibilities;
- ✓ **Mandatory Assisting**: There are many issues / concerns arising in relation to mandatory assisting governance issues, resource implications for organisations, etc.
- ✓ **Children First Training**: All staff members / volunteers should complete the on-line children first module on HSELand.
- ✓ **Children First Compliance**: The HSE will be requesting all Services to compete a 'compliance check-list' to ascertain their level of compliance with the CF Legislation.

#### **National Federation IT Sub Committee**








### **General Data Protection Regulation**

The General Data Protection Regulation (GDPR) will come into force on the 25th May, 2018, replacing the existing data protection framework under the EU Data Protection Directive. As a regulation, it will not require transposition into Irish law, so we as organisations involved in data processing need to be aware that these regulations apply directly to us in terms of the obligations they impose. The GDPR emphasises transparency, security and accountability by data controllers and processors, while at the







It will affect how we do business and we all need to be aware of the consequences of any breaches as the penalties are quite substantial. As organisations that hold substantial amounts of data on individuals and groups we will be monitored and audited by the Data Commissioner's Office and we need to be prepared to meet the standards set out in the GDPR.

The National Federation has held a number of information sessions/training days to highlight the main aspects of the GDPR and what organisations should be doing to prepare for this regulation. We

have also set up a Data Protection Network comprising of representatives from member organisations. The purpose of this Network is to support the Members of the National Federation in understanding and meeting the requirements of the Data Protection Acts and the new General Data Protection Regulation (GDPR) prior to its implementation date in May 2018.

#### Postgraduate Diploma in Child Protection and Welfare





**Programme Information:** This national, multi-disciplinary, in-service course is sponsored by the Child and Family Agency and is aimed at experienced, professionally qualified personnel who carry regular responsibility for management/training/frontline delivery of child

protection and welfare services under the Child Care Act 1991, the Children Act 2001 and related legislation. Course participants normally include service managers and supervisory/main grade professionals (social workers, public health nurses, psychologists, doctors, Gardaí, child care workers, speech and language therapists, teachers, lawyers, youth and project workers, etc.). A second year leading to a M.Sc. in Child Protection and Welfare is available to eligible candidates who have completed the Postgraduate Diploma with a 2.1 or better result.

**Entry criteria**: All Applicants must have a degree or equivalent professional qualification. In addition, a minimum of three years' professional experience working with some aspect of child protection and welfare is required. You must submit a 1500 word personal statement on why you

wish to undertake the programme and should receive the scholarship as part of your application. Applications are completed online.

**Course Duration:** The course runs for nine separate weeks spread over the academic year, with full attendance in college for approximately one week in four. This involves students attending classes Monday-Friday, 9am-6pm. Full attendance at College is compulsory.

# Free online course from Trinity College Dublin aims to improve health assessments for people with an intellectual disability




The Trinity Centre for Ageing and Intellectual Disability at Trinity College Dublin is launching a new Massive Online Open Course (MOOC) geared to healthcare professionals, care providers and others who work with people with an intellectual disability. This MOOC is partially-funded by the European Institute of Technology through their Health Knowledge and Innovation Community (EIT Health) which was established in 2008 to promote innovation and entrepreneurship across Europe.

For decades, health and health care inequalities among people with an intellectual disability have been an issue, due to inaccessible healthcare information and service provision. These challenges can increase exclusion from preventative screenings, delay regular health assessments, impact on quality of life, and further marginalise people with an intellectual disability. Trinity's free three-week online course will explore how to improve health assessments for people with an intellectual disability. #### **Ability West honours the Presentation Sisters for their Donation**

Nine members of the Presentation Sisters visited Ability West in Blackrock House, Salthill, Galway, on 19<sup>th</sup> February for the unveiling of a plaque in recognition of their generosity in donating the building to the organisation in 1999.

Ability West (formerly Galway County Association) has been providing services and supports to children and adults with intellectual disability in Galway City and County for over 55 years. The organisation was first granted use of Blackrock House in 1979. For a number of years it was used to provide adult residential and day services, as well as respite on weekends. Today, the building is occupied by Ability West's administrative headquarters, and the ground floor is used as a day service for adults. Ability West now has 58 centres in 13 geographical locations, and supports over 540 people with intellectual disability and autism.

The Presentation Sisters are closely linked with the history of Blackrock House. They first tried to set up a school there in May 1833, but it closed after a year due to a shortage of students. The house was later owned by the Hynes family, and was ultimately left to the Presentation Sisters by Sister Joseph, who was born Kathleen Hynes and was left the house by the Hynes Family.



#### **National Ability Supports System (NASS)**

The National Intellectual Disability Database (NIDD) and the National Physical and Sensory Disability Database (NPSDD) have been merged into one system – National Ability Supports System (NASS). The purpose of NASS is to capture information about the use and need for disability services in order to aid the planning, development and organisation of these services. Those in receipt of or requiring a disability-funded service and who have a physical, sensory, neurological, behavioural/learning (including autism), speech/language and/or an intellectual disability should be registered on NASS.



#### Why merge?

Licence and hosting issues had arisen with the two existing systems which needed to be addressed and this was an opportune time to merge. It also provided the opportunity to reflect changes in service provision arising from New Directions, Time to Move On and other initiatives designed to provide for individualised supports and services and allows for inclusion of service users with autism and those with physical and sensory disabilities aged 65+ years. Third party data upload will be available for disability service providers.

All service providers and data managers will require training on completing the new form accurately, as well as how to use NASS software, this will be delivered by the Health Research Board (HRB).

#### New Irish Research about Communication and Lámh Signing

Lámh signs are used by children and adults with intellectual disability and communication needs in Ireland.

The inaugural Lámh Research Seminar was held recently in Dublin. Key presentations at the Lámh Research Seminar were by Lámh Scholars who received small grants from Lámh: (1) 'Lámh: The Parents' Experience' was presented by St. Angela's College, Sligo and (2) 'Staff Attitudes about Lámh signing - a whole organisation review' was delivered by a team from COPE Foundation, Cork.

Over the past 2 years, Lámh had made a small grant available in order to promote research about Lámh and to explore how Lámh users, their families and other communication partners can be best supported. More information about upcoming support for research on Lámh will be available on our website in the coming months.

Other presentations at the Research Seminar included experts by experience who spoke about how Lámh sign users, peers and families are involved in awareness raising, training and research, and peer attitudes towards the use of key word signing by children with Down syndrome in mainstream schools.
