HSE Safeguarding Vulnerable Persons at Risk of Abuse — National Policy & Procedures, 2014

As service providers we need to ensure that those we support are treated with dignity and respect, that we effectively support people to live ordinary lives and promote people's welfare and safeguard them from potential harm. There is an obligation on organisations to ensure that all staff and volunteers are clear as to their role and responsibilities in relation to adult safeguarding and the actions they need to take if a safeguarding concern arises.

This conference will provide delegates with the opportunity to hear from leading experts in the field of safeguarding, to network and discuss issues / concerns relating to adult safeguarding. In particular it will focus on:

- Relevant national policies and key legislation implications and legal responsibilities;
- HSE's priorities for safeguarding vulnerable persons / update on the work of the Safeguarding Office & the HSE Confidential Recipient;
- The importance of organisations' culture in supporting a no tolerance approach to safeguarding;
- HIQA expectations on residential service providers in the delivery of safe services for adults and the management of incidents;
- Issues arising for service providers in supporting adults and dealing with safeguarding concerns.

A particular highlight of the event will be the launch of the Online Safeguarding Module for staff and volunteers which has been developed by the National Federation of Voluntary Bodies, St. Michael's House & the Open Training College.
